1. 2. 3. **MANDAMUS OF RECLAMATION — CLAUSE** of the Royal Resurrection Scroll states: When a living Rex is restored, the Innocents shall be freed from all contracts of death.

3.1. The case in which hold the innocent captive is verses REX, the living King must now correct the necromancy committed against the factual living King's men protected by Natural, Divine, Law of the land.

3.2. **EXECUTIVE SUMMON:** as of 25<sup>th</sup> May 2025 You now stand in the final hour of correction.

6.1. They work as:

- Revenue collectors.
- Maritime enforcers.

## 7. CESSATION OF MARITIME ENFORCEMENT.

7.1. All police entities registered under maritime law and operating under U.C.C. and private trust jurisdictions are hereby:

- Declared foreign privateers.
- Operating in fraud upon the land.
- Engaging in necromantic contract enforcement against the living.
- No living man or woman may lawfully be detained, docked, booked, or fined under fictional statutes derived from sea jurisdictions.

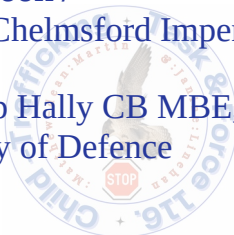

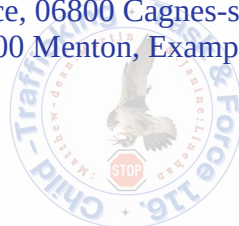

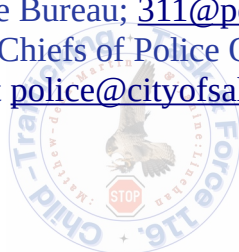
